

Immunization Documentation-Required for EMS & Allied Health Clinical Rotations

The following immunizations and tests are required for entry into your clinical training and to maintain your ability to function as a student in the clinical settings.

<u>TB/ PPD Mantoux (Tuberculosis)</u>: This test is required for students of <u>ALL</u> programs American Professional Educational Services offers and must be current throughout your clinical rotation time. This test is valid for a period of 6 months to one year. Depending on the facility, this test may have to be repeated prior to starting or finishing clinical time. Documentation must be attached to the physical release form.

<u>Influenza</u>: *This vaccination is required for all Paramedic and Allied Health (CNA, EKG Technician, and Phlebotomy) students* and must be current throughout your clinical rotation during flu season (October to May). It must be received at the beginning of the season or prior to the start of clinical rotation.

MMR (Measles, Mumps, Rubella): All *Paramedic students* must provide proof of immunization for MMR. You are required to have received two (2) sets of injections. Most people receive these shots in early childhood, and then have them repeated later in their teens or pre-college years. If you are unable to obtain documentation, a physician can order a blood test requesting a MMR titer. Documentation must be attached to the physical release form.

Chicken Pox (Varicella): All Paramedic students must provide proof of immunization for Varicella. Most people receive these shots in early childhood, and then maybe repeated later in their teens or pre-college years. If you are unable to obtain documentation, a physician can order a blood test requesting a Varicella titer. Documentation must be attached to the physical documentation form.

<u>TD (Tetanus):</u> All *Paramedic students* must provide proof that they have received a tetanus booster within the past 5 years. Documentation must be attached to the physical release form.

<u>Hepatitis B</u>: All *Paramedic students* will need documentation that they have received this three (3) part injection series, or at a minimum have started the process. It is strongly recommended that all paramedic students receive this vaccination. A student may opt not to have this vaccination; however, a signed and witnessed affidavit of waiver must be completed and kept on file with American Professional Educational Services. Documentation must be attached to the physical release form.
